

Land Trust Alliance of British Columbia: Nature Photo Contest

Submission dates: July 1-Sept 6

1. The promoter is the Land Trust Alliance of British Columbia LTABC whose registered office is at 201-569 Johnson Street Victoria BC.
2. Employees of LTABC or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition.
3. There is no entry fee and no purchase necessary to enter this competition.
4. Contest entries are to be emailed to devofficer@ltabc.ca and must include the location of the photo, photographer's name, prize category entered, address, telephone, email contact and whether they are an amateur or professional photographer. The file must be sent in a JPEG file. Multiple submissions are accepted. By submitting a photo to the contest the entrant agrees that he/she is the original photographer of the entry, that they have the right to submit the photograph and that LTABC is authorized to use the photograph in any format they choose in the operations of LTABC for a period of not less than 3 years. Photographers agree to a royalty free copyright to LTABC.
5. Closing date for entry will be 12 noon September 6, 2017. After this date no further entries to the competition will be permitted.
6. No responsibility can be accepted for entries not received for whatever reason.
7. The rules of the competition and the prize for each winner are as follows:

One prize for overall photograph winner	Prize \$150
One prize for best amateur photograph	Prize \$150
One prize for best professional photographer	Prize \$150
One prize for best wildlife shot	Prize \$150
One prize for best people in nature	Prize \$150
One prize for best landscape	Prize \$150

One prize for best youth photograph (age 18 and under) Age must be included with submission. Prize \$150.

Judges may award one Second Place prize in each of the categories. Prize is \$50 per category.

Each main category may also have one Honorary Mention receive the pictorial book CANADA (Value \$50).

Winners will have their work published on the LTABC website, e-news, Facebook and in print in a future LTABC publication (provided quality of photograph is sufficient).
8. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual

or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control. Any changes to the competition will be notified to entrants as soon as possible by the promoter.

9. The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.

10. No cash alternative to the prizes will be offered. The prizes are not transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.

11. Winners will be chosen by an independent panel of judges appointed by the Promoter.

12. Winners will be notified by email and/or letter within 28 days of the closing date. If the winner cannot be contacted or do not claim the prize within 14 days of notification, LTABC reserves the right to withhold the prize from the winner and pick a replacement winner.

13. The promoter will notify winners when and where prizes can be collected.

14. The promoter's decision in respect of all matters to do with the competition will be final and no correspondence will be considered.

15. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
