Steve is from the buffalo clan, is Anishinaabe/Saulteaux. and is from the Ebb and Flow First Nation and Lake Manitoba First Nation. both in Manitoba. Steve is an award-winning professional and entrepreneur with expertise in mapping and geographic information sciences, business development, natural resources management, and project management. He has mentored Indigenous practitioners, conducted risk assessments, built decision-support systems and monitoring tools, supported land claims, developed best practices, established consultation processes. facilitated community engagement and planning approaches, and supported negotiations between Indigenous communities, governments and industries.

Steve is a board member of the Canadian Urban Institute, an advisory board member of the Institute for Integrative Conservation at William & Mary, a moderator of the Open Forum on Participatory Geographic Information Systems and Technologies, and a trainer of the Google Earth Outreach Trainers Network.

Harvey McKinnon President, Harvey McKinnon Associates

Harvey is recognized as one of North America's leading fundraising experts. He is the author of five acclaimed books, and is the co-author of the #1 international best-seller *The Power of Giving: How Giving Back Enriches Us All.* It won the Nautilus Gold Award for books on social change and the book was also one of Amazon's Best Books of the Year.

Harvey is considered a world leader on monthly giving. He has written two books Hidden Gold and his latest book How to Create Lifelong Donors Through Monthly Giving, released in 2020.

He is a highly rated trainer and has taught fundraising to thousands of non-profit staff. A frequent speaker at conferences including: the AFP International (where he was tied for the highest rated out of over 100 speakers).

- He has produced a wide variety of award-winning documentary films that have been aired on the BBC, CBC, ABC, and PBS.
- Before founding Harvey McKinnon Associates in 1989, Harvey spent ten years with Oxfam Canada.



The Honourable Nathan Cullen Minister of Water, Land and Resource Stewardship, Province of BC

Nathan Cullen was elected MLA for Stikine in the 2020 provincial general election and is Minister of Water, Land and Resource Stewardship. He previously served as Minister of State for Lands and Natural Resource Operations, as Chair of the Environment and Land Use Committee and a member of the Cabinet Committee on Economy.

Nathan proudly served as Member of Parliament for the riding of Skeena-Bulkley Valley for 15 years, from 2004 to 2019.

During his time in Ottawa, Nathan was named a Parliamentarian of the Year multiple times, served as Official Opposition House Leader, and held opposition critic roles for Finance, Ethics, Environment, and Democratic Reform.

Nathan has worked to encourage the participation of young people in politics, the creation of new laws, and has supported young entrepreneurs in the Northwest in starting and growing their businesses.
